## IV. UNIV 3820 Course Review

a. BCLC Mentorship Course

- a. Syllabus/proposal was revised to clarify the committee's previous questions and address previously raised concerns. Requested course size is to require all 60 BCLC students and offer as optional to all School of Business students for a class seat level of 100. Committee recommends 5 individual sections to maintain the UNIV course suite seat limits of 19. Additional considerations from the committee are to clarify the course requirements on field trips
